To vote for a person whose name does not appear on the ballot, write the person's name on the line provided and completely darken the oval to the LEFT of the person's name like this . To vote on a question, completely darken the oval to the LEFT of "YES" if in favor of the question, or completely darken the oval to the LEFT of "NO" if opposed to the question.
