AN ORDINANCE RELATING TO ALL NIGHT PARKING REGULATED,
PROHIBITED PARKING AND TWO HOUR PARKING REGULATED

Introduced by Alderman Wisneski

The Common Council of the City of Menasha does ordain as follows:

SECTION 1: Section 10-1-29 (a)(4) is amended by adding the following:
“and the south side of Center Street from the cul de sac to 420 feet east”

SECTION 2: Section 10-1-27 (a) (1)(5)(19)(25)(26) is repealed and renumber
succeeding sections accordingly:

SECTION 3: Section 10-1-26 (ddd) is repealed and renumber succeeding sections
accordingly:

SECTION 4: Section 10-1-26 (eee) is amended to read: North side of Center Street

SECTION 5: Section 10-1-27 (a)(27) is repealed and renumber succeeding sections
accordingly:

SECTION 6: Section 10-1-27 (a)(9) is amended to read: Center Street south from Main
Street 250 feet south, except as covered by 10-1-27 (f)(5).

SECTION 7: Section 10-1-27(f)(4)(10)(11)(12)(13)(14) is repealed and renumber
succeeding sections accordingly.

This ordinance shall be come effective upon its passage and publication as provided by law.

SEC. 10-1-26 PROHIBITED PARKING

No person shall park or leave standing any vehicle upon any of the following highways, streets or parts thereof, except temporarily for the purpose of and while actually engaged in receiving or discharging passengers.

~~(ddd) North side of Water Street from Mill Street to the Marina.~~

~~(eee) North side of Water Street from Center Street westerly to a point two hundred-thirty (230) feet east of Tayco Street.~~

SEC. 10-1-27

When signs or parking meters are erected in any block giving notice thereof, no person shall park or leave standing any vehicle for longer than the period specified upon any of the following highways, streets, or parts thereof, except temporarily for the purpose of and while actually engaged in receiving or discharging passengers. However, this provision shall not apply to Saturdays, Sundays and legal holidays.

(a) **PARKING FOR MORE THAN TWO (2) CONSECUTIVE HOURS.**

~~(1) North side of Water Street from Tayco Street to a point one hundred fifty (150) feet east of Tayco Street.~~

~~(5) South side of Water Street between Tayco and Center Streets, excepting an area which runs from Tayco Street to a point one hundred fifty (150) feet east of Tayco Street on the south side of Water Street.~~

~~(19) The south side of Water Street from Mill Street to the Marina.~~

~~(25) North side of Water Street between Tayco and Center Streets to a point one hundred fifty (150) feet east of Tayco Street.~~

~~(26) South side of Water Street between Tayco and Center Streets, excepting an area which runs from Tayco Street to a point one hundred fifty (150) feet east of Tayco Street on the south side of Water Street.~~

~~(27) Center Street between Main Street and Water Street except as provided by 10-1-27(h)(11).~~

~~(9) Center Street between Main Street and Water Street, except as covered by 10-1-27(h)(5). South from Main Street 250 feet south, except as covered by 10-1-27(f)(5).~~

(f) **SPECIAL PARKING RESTRICTIONS.**

~~(4) There shall be no parking on Third Street from Racine Street to DePere Street from 6:00 a.m. to 6:00 p.m., except Saturdays, Sundays and holidays.~~

~~(10) No person shall park any type of vehicle which has been used for hauling, towing or launching any boat at any boat launching site without having obtained the boat launching permit required by Sec. 12-2-3(b) of the Menasha Ordinances.~~

~~(11) No person shall park any vehicle within an attached trailer on the north side of Paris Street between Manitowoc Street and DePere Street.~~

~~(12) The northern seven (7) stalls on the east side of Center Street and north of the Harbor House are restricted to vehicles with a Menasha Marina sticker from May 1 to September 30.~~

~~(13) Marina parking permits are valid in any City lot in the same manner as the City parking permit.~~

~~(14)~~

~~a. No person shall park or cause to be parked, any automobile, truck, or other vehicle whatsoever as it becomes necessary, at the discretion of the Police Department for a period of One (1) hours, before and until one (1) hour after events at Calder Stadium on the following described streets: the North side of Eleventh Street from Appleton Street to DePere Street.~~

~~b. The prohibition of parking along streets under the above provisions shall become effective by police direction and/or appropriate signs and barricades.~~

~~c. This section does not rescind any parking regulation already in effect in the above described streets.~~

Note: Sections 10-1-27(f)(10)(11)(12)(13)(14) are being repealed because they are duplications of Sections 10-1-27(f)(8)(7)(5)(6)(9) respectively.

Section 10-1-27(f)(4) is being repealed because it was superceded by an agreement with WisDOT regarding prohibiting parking along that section of Third Street.
